The Spark committee met with the Commissioners. Cheryl Goetz reported on the receipts coming in from the schools, cities and the county. Schools are on track for opening. The plan has been sent into the state. They reported on the second round of grant money. The applications have all been sent into the state for review. The committee left the meeting at 9:35 a. m.

David Mendenhall and Denise Wolf joined the meeting at 9:35 a.m. Dave reported on the resurfacing done in Grinnell. Discussion was held on resurfacing needed in Grainfield. Dave will report back to the City Council. Denise presented the voucher summary. Duane made a motion to go into executive session for 5 minutes to discuss non-elected personnel. Chuck seconded the motion. The motion carried by a unanimous vote. The Commissioners returned to regular meeting at 9:50 a.m. Dave and Denise left the meeting at 9:50 a.m.

Corina noted the following items are needed to submit the request. notarized affidavit of publication for the conflict of interest hearing, unofficial typed minutes of hearing and the attorney's original determination letter.
