Mark Schmeidler joined the meeting at 11:30 am.

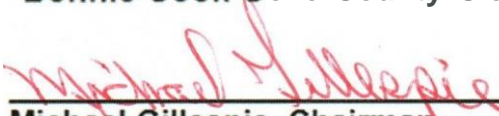

The Commissioners returned from lunch at 1:08 pm.

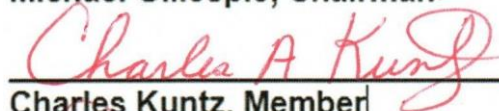

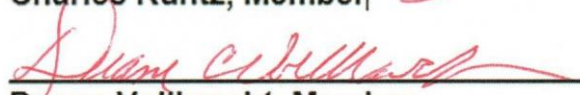
